- Draft Health Sector PPP Policy Guidelines drafted with PPP TWG involvement
- Draft PPP Policy Guidelines aligned to National PPP Policy, PPP Act and the PPP Regulations
- PPP Office established and supported by development partners

# PPP TWG SUPPORT TO STRATEGIC OBJECTIVE 2

### To ensure effective management and operational framework for PPP

- Review of SA implementation was conducted wherein successes and challenges were identified.
- Health Sector PPP Strategic Plan
- Nine monthly national level PPP TWG meetings held
- Existence of PPP Forums in few regions
- Draft PPP Orientation Manual was developed

# PPP TWG SUPPORT TO STRATEGIC OBJECTIVE 3

## To enhance PPP in the provision of health and social welfare services

- Participation in the revision of CCHP Guidelines
- Draft ToR for NPPPCC was prepared
- 4Regions and 12 councils were sensitized on the importance of Service Agreements and PPP in general including the establishment of PPP forum
- 17 Councils signing Service Agreement with private facilities to provide public health services
- Government pays staff grants of DDH and VA staff
- Draft PPP Tracking Framework prepared
- Private Health Sector Assessment started

### **CHALLENGES AND CONSTRAINTS**

- Relevant reference policy and legal documents (national level) released intermittently and kept being revised during the entire year.
- PPP Tracking Framework dependent upon implementation of PHSA which was delayed.
- Inadequate PPP mindset among key stakeholders.
- Costing of health services and source of fund for implementing Service Agreement

#### **WAY FORWARD:**

- Develop PPP Implementation Strategy in line with the revised PPP Policy Guidelines.
- Promote PPP Forums in health sector at all levels and in particular at LGA level.
- Support councils in mainstreaming PPP in comprehensive council health planning process.
- Finalize ToR for National PPP Coordinating Committee
- Integrate PPP indicators in HMIS tool
- Implement PHSA and improve draft PPP tracking framework
